Resolution No. 7 On Marijuana and Other Illicit Drug Use

Resolution No. 11

On the Lottery and Gambling

We, the messengers to the 2014 Baptist General Convention of Oklahoma, meeting at Quail Springs Baptist Church, Oklahoma City, Oklahoma, November 10-11, 2014, are deeply concerned about the rise in casino gambling in Oklahoma, and we believe gambling is addictive, wasteful and has a negative effect on communities and families. Ten years ago, Oklahoma voters approved a state-sponsored lottery based on promises of substantial additional funding to schools. Recent news reports from *The Oklahoman* and other sources have established that the projected revenue estimates by policy leaders at the time have fallen woefully short by tens of millions of dollars. Oklahoma Baptists and others at that time provided a consistent voice of caution against a state lottery and the dangers of gambling. We urge pastors and churches to educate people about the spiritual, financial and moral dangers of gambling, and we pray this trend of increased gambling stops.
