Oklahoma Baptists commend and resolve to support the ministries of Oklahoma Baptist Homes for Children and Baptist Village Communities for valuing and enhancing all human life.

Resolution No. 4 On The Unborn

Resolution No. 8 On Christian Citizenship

We, the messengers to the 2011 Baptist General Convention of Oklahoma, meeting at First Baptist Church, Moore, Oklahoma, November 14-15, 2011, in recognition of the 2012 national and state elections, want to encourage Oklahoma Baptists to fulfill their God-given responsibility to participate in the political process by registering to vote, being informed, and voting in accordance with Biblical values. We support Christian men and women who pursue positions of public leadership and service within the government at all levels. Resolution No. 9 On Hunger
